



**TUITION AND FEE SCHEDULE for the 2017-2018 Academic Year
New Families**

Annual Registration All Registration payments are non-refundable.

New Students \$950.00 per student

Annual Technology Fee \$150 per student grades K-4 and \$350 per student in grades 5-8.

The fee must be paid by August 20. *This fee is in conjunction with the Mobile Learning Device Agreement and assists with the use and replacement costs of our classroom mobile learning devices.*

Annual Tuition – Grades Kindergarten through Eighth

One Student \$9960.00

Second and Subsequent Students \$8964.00

Tuition is non-refundable. The annual Enrollment and Tuition Agreement is binding.

Tuition Payment Options

All payments are made through TADS

Annually by August 20, 2017

Bi-annually First Semester by August 20, 2017 and Second Semester by January 20, 2018

Ten monthly automatic drafts to TADS to be paid in full by May 20, 2018

Late tuition payments will be assessed late fees and/or consequences according to the Enrollment and Tuition Agreement.

The annual tuition and registration fees cover most costs except school uniforms and school lunches. Lunch accounts are paid directly to the school lunch vendor. *Lands End* and *Parker School Uniforms* are the school uniform providers. You may order *Lands End* online or visit the *Parker School Uniform* store. Some field trips and extra-curricular activities occurring after school, such as but not limited to athletics in grades 5 through 8, will have an additional fee.

Special Services programs such as educational therapy (diagnosed learning differences and dyslexia), RTI (Response to Intervention), and specific enrichment programs, are at an additional cost to our school families. These programs are offered in addition to our formal school curriculum. *Please see the specific information for a detailed description.*

Additional fees will be charged to the TADS account. Family Volunteer Work Service hours are tracked through the Tads account.

Tuition Reduction

A pre-determined amount of funds is available for assisting families with tuition costs. Qualification is based on need as determined by a third party evaluation through the submission of a confidential assessment form and the most recent IRS 1040. Families seeking tuition reduction must submit the necessary information and forms (confidential assessment application and IRS 1040) **online to TADS (Tuition Aid Data Service)** by the *required date*. There is a fee for this process. Families will then be notified by email in late spring/early summer as to the amount of tuition reduction granted. Should families need to discuss their tuition reduction further, they must call the school office and set up an appointment with the school commission. Late enrolling families seeking reduction assistance may apply but funds may be limited and subject to review and approval by the school commission. *Registration payments and technology usage fees cannot be considered for reduced tuition.*
